Paul's treatment of how Jews are now made right with God continues. The fact that he is even dealing with this issue reveals at least two things: firstly, no one is given right standing with God by virtue of their ethnicity (or what nationality or race they belong to); and, no one is automatically saved (as 'Universalists' claim).

This is why the teaching of God's Word in the church is of paramount importance! Without right knowledge of God from His Word, there can not be right *beliefs* and without right beliefs there cannot be right *trust in God* and without right trust in God there can be no *salvation*. This is Paul's point in Romans 10:4.

3. What did Hosea warn was the consequence of being ignorant about God's Word? (Hosea 4:6)

THE LAW

Romans 10:4 states that *Christ is the end of the law*. This is not teaching that since Christ came there is now no more commands of God to be kept. Rather, the *end of the Law* means that the point or purpose of the Law has been fulfilled. Jesus Christ not only perfectly kept all of the Laws of God, He perfectly fulfilled what they were shadows of. This includes all of the Law's ceremonies and sacrifices.

Paul asks who is righteous and powerful enough to summon Christ to come down from heaven and die for sins, and then to raise Him from the dead (Romans 10:6-7)? The rhetorical answer is: *no one*. Paul says that, rather, our power to be forgiven and the righteousness which results is by *faith* (or *trust* in Christ and His finished work).

In some religions it is necessary to travel great distances and perform great deeds to find *salvation*.

	Romans 10:9 is a great memory verse for Christian workers. It reveals how people

receive God's offer of salvation. Noting this verse, when the Holy Spirit moves on a person, how do they respond to God's offer of salvation?

When a person receives Christ as Saviour, they do so by *trusting* Him ("believing in their heart") so that they are *justified* - acquitted of their sin-guilt by virtue of Christ's righteousness (Romans 10:10).
